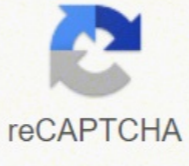


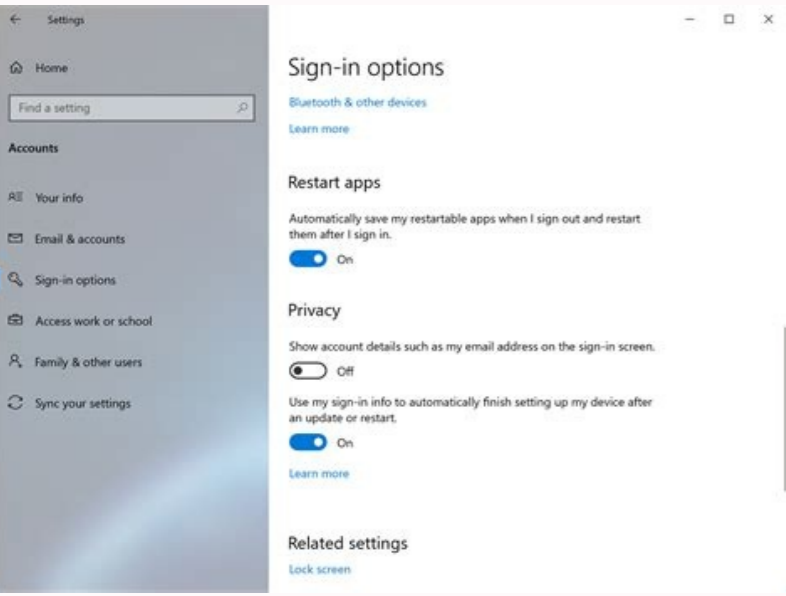
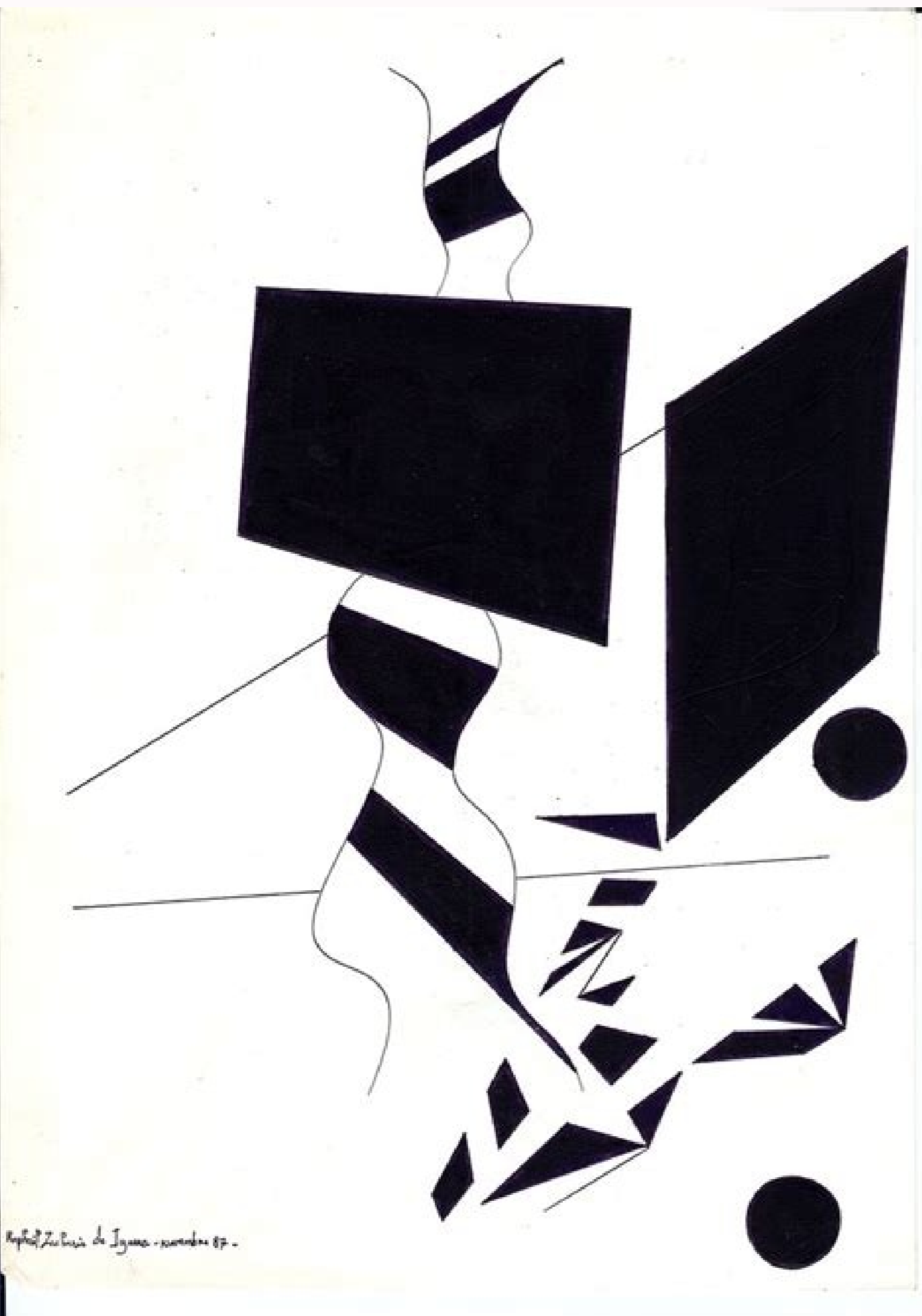

If you decide to do so, be sure to change the wording of this section as needed. In signing this Agreement, the Agent agrees to not do any of the following: disclose to a third party any details regarding the Company's business, including without limitation any information regarding the Company's customer information, business plans, or price points (the "Confidential Information"), make copies of any Confidential Information or any content based on the concepts contained within the Confidential Information for personal use or distribution unless requested to do so by the Company; use Confidential Information for anything other than the benefit of the Company; immediately upon termination of the relationship between the Company and the Agent, the Agent shall return to the Company any documents about the Company's business and any of its trade secrets that are in the Agent's possession. Exclusivity The Agent shall be the exclusive party authorized to market the Products within the Territory as part of the client-agency relationship. 4. Trademark Rights The Agent agrees and acknowledges the following regarding the Company's trademark: The Company is the sole and exclusive owner to all rights (including all intellectual property rights), titles, and interest in "[Sender.Trademark]" or to any other trademarks associated with the Company (the "Company Trademarks"), which the Agent may utilize in performing the services herein. Upon termination of the Agreement, the Agent will continue as valid and enforceable. 12. Through natural termination, which means that either Party can terminate this Agreement due to the other's breach of this Agreement, insolvency, liquidation, bankruptcy, death, or disability. Indemnification If you want to have the Agent protect against losses, consider adjusting this section so it is more of a Hold Harmless clause. If this is an exclusive agency, which means the Agent is the Company's only authorized agent for marketing the products in the territory, and the Company agrees not to appoint other agents in the same territory, you can add "as the Company's sole and exclusive agent." NOW, THEREFORE, in consideration of the mutual covenants and promises made by the parties hereto, the Company and the Agent (individually, each a "Party" and collectively the "Parties") covenant and agree as follows: With certain limitations stated hereunder, the Company hereby authorizes the Agent the right to market and offer for sale the Products according to the terms and limitations stated in this Agency Agreement. Parameters can be set as to how much authority an agent has, and they should be agreed upon by both parties. An agent agreement is essentially a fiduciary agreement, which means the agent must carry out the assigned tasks in the principal's best interest. 10. "Net Product Sales" shall be defined as the amount of sales revenue from any sales made by the Agent, less any chargebacks, returns, or defaults by customers. Should the Parties terminate this Agreement for any reason, giving written notice of the termination, the Company shall pay the Agent only for sales of the Products made before the termination date. The last sentence is for situations in which the Agent and the Company are working in regulated industries such as law, medicine, or immigration. This section will remain in full force and effect even after this Agreement has been terminated by either Party. Both Parties acknowledge that this Agreement does not create a joint venture or partnership between them and that this Agreement is solely a contract for service. 8. Inspection and Approval This section is for ensuring that the Agent's obligations under this Agreement meet your standards. Term and Termination This Agreement shall commence upon the Effective Date and continue until either Party terminates this Agreement in writing. It can be used for any kind of agent-principal relationship between businesses or individuals, but is used most notably in marketing and real estate transactions. Nothing in this Agreement will be construed to create an employer-employee relationship between the Company and the Agent.
